

Notification – Registration for Supplementary Examination - 2025-2026 Even Semester

- Registration for Supplementary Examination - **2025-2026 Even Semester** is as follows:
 - Start Date: 18-03-2026 at 04:00 p.m.**
 - End Date: 25-03-2026, 10:00 a.m. (including Fee payment)**
- **Students must pay prescribed amount of fee to register and attend the supplementary examinations.**
- **No registration or fee endorsement request will be entertained after 25-03-2026, 10:00 a.m.**
- **Department Endorsement is not required to complete the Supplementary Registration.**
- **Students having arrears in the courses that are running in the current semester must register and attend the supplementary examination along with the end semester examination, as per the timetable (*End Semester timetable will be published soon*).**
- **Note:** - *Students with arrears may have two exams on the same day in different sessions. If two exams fall on the same day in the same session, the student will be allowed to deregister one course from Academic Cell on mail request, and the refund request will be proceeded through Accounts Office.*
- **Queries related to time table must be emailed to exams@am.amrita.edu, registration queries must be emailed to acadcoord@am.amrita.edu only and fee queries must be emailed to radhikah@am.amrita.edu.**

Note:-

- **For School of Computing**
 - **Normal Supplementary:** Students who have not exhausted the 4 attempts (Regular + 3 consecutive Supplementary attempts)
 - **100 Supplementary:** Students who have exhausted 4 attempts (Regular + 3 consecutive Supplementary attempts)
- **For Schools other than Computing:**
 - **Normal Supplementary:** Students who have not exhausted the 4 attempts (Regular + 3 consecutive Supplementary attempts)
 - **100 Supplementary:** The clause, R.15.1, mentioned in the B.Tech. regulation 2023 regarding the supplementary examinations, **will be applicable for all the students**

(Except Students from School of Computing) admitted prior to 2023 admissions also.

A Student, who has secured an 'F' grade in a course can register for supplementary examination with internal marks secured during the regular semester or can register for 100 marks supplementary examination where the internal marks will not be considered. If a student opts to register for 100 marks supplementary examination, and fails, then he/she should continue in 100 marks supplementary mode and can't revert to supplementary with internal marks. The only option after 100-mark supplementary exam attempt(s) is to reregister for the course whenever the course is offered by the respective department. This is applicable only for the theory courses (example: courses with L-T-P's: 1-0-0, 2-0-0; 2-1-0, 3-0-0; 3-1-0; 4-0-0)

All the Students, **(Except Students from School of Computing)** who are unable to register the supplementary courses under **100 supplementary category through AUMS**, need to complete fee payment for the required supplementary courses and forward the fee paid details along with the course details to **acadcoord@am.amrita.edu**

- **Students who were caught for Malpractice in any course(s) and whose registration of that particular subject was cancelled, are not eligible for Supplementary registration, of that course(s), under any of the supplementary registration Category. They can proceed to register for such courses, either by re-registration or runtime redo.**
